As of 5:00pm on May 28, there have been 75 confirmed community cases of COVID-19 in the Town of Boonton and one COVID-19-related death. Active community cases are recovering at this time and are receiving treatment as necessary. Negative test results have been reported for 305 individuals.

In an outbreak isolated to a long-term care facility in the Town of Boonton, there have been 38 confirmed cases and 23 COVID-19 related deaths. As with COVID-19 in the community, cases associated with the long-term care facility are recovering and receiving treatment.

Town of Boonton health officials are following all appropriate NJ Department of Health (NJDOH) and Centers for Disease Control and Prevention (CDC) protocols in conducting efficient and comprehensive follow up. Individuals who have tested positive for COVID-19 have been contacted by the Town of Boonton Health Department, are isolated from the public per federal/state guidelines and are being monitored in accordance with NJDOH and CDC requirements to ensure compliance with all protocols in protecting our community.

Please be advised that per established guidelines, household contacts and close contacts of individuals who test positive for COVID-19 are contacted by the Town of Boonton Health Department, are asked for information, and are furnished with instructions for quarantine and monitoring.

Please note: Federal and state law strictly prohibits the release to the public of private health information of any individual, including the name, address or any other identifying information specific to those who test positive for COVID-19. The Town of Boonton maintains compliance with all applicable local, county, state and federal regulations.

Persons who have tested positive for COVID-19 are isolated from the public. Persons who may have COVID-19 but do not yet have symptoms are *not* under isolation and still may move freely in public, in accordance with the Governor's applicable executive orders. Therefore, for your protection and for the protection of those around you, please:

- Continue to stay home
- Comply with social distancing measures
- In public settings where social distancing measures are difficult to maintain, it is recommended to wear cloth face coverings
- In settings where an essential retail business is permitted to maintain in-person operations, customers and workers are to wear cloth face coverings while on premises
- Wash hands frequently
- Cough/sneeze into a tissue or your sleeve instead of hands
- Self-monitor for symptom
- If you experience symptoms (fever of 100.4°F, cough, shortness of breath), please call your healthcare provider for guidance

Inasmuch as current data is available, the Town of Boonton will continue to update the public regularly regarding the status of cases within Boonton, Morris County, New Jersey and the United States.

Definitions:

Household contact: *Defined as a person who lives in the same household.*

Close contact: *Defined as a person spending a prolonged period of time within approximately six feet (6') of a confirmed case (i.e., caring for, living with, visiting or sharing a healthcare waiting area or room) or having direct contact with infectious secretions of a confirmed case (such as being coughed or sneezed on), in the time period from three days (72 hours) prior to onset of a case's symptoms until the beginning of isolation of the case.*

Casual contacts: *Defined as other persons who may have had casual contact with someone who has tested positive for COVID-19 (i.e., sharing the same indoor environment, like a lobby or office, for a period of time; occupying the same room briefly). Please note that casual contacts will not be contacted by the Health Department and are not placed under quarantine. These persons should continue to follow all applicable orders (from State, Morris County and/or municipal government), comply with social distancing measures, maintain hand hygiene and respiratory etiquette, and self-monitor for symptoms (fever of 100.4°F or higher, cough and/or shortness of breath).*
