**RESOLUTION 20-302**

**RESOLUTION OF THE MAYOR AND BOARD OF ALDERMEN OF THE TOWN OF BOONTON APPROVING THE TERMINAL LEAVE OF LIDIA IENARO AND ACCEPTING AND RELYING UPON LIDIA IENARO'S RETIREMENT.**

**WHEREAS**, the Town Administrator received correspondence from Lidia Ienaro on December 15, 2020 advising that she will be retiring from the Town of Boonton; and

**WHEREAS**, Ms. Ienaro has advised that her retirement shall be effective May 1, 2021; and

**WHEREAS**, Ms. Ienaro requested to be placed on terminal leave in accordance with the Employee Handbook; and

**WHEREAS**, Ms. Ienaro executed the Terminal Leave Agreement on December 15, 2020; and

**NOW, THEREFORE BE IT RESOLVED**, by the Mayor and Board of Aldermen of the Town of Boonton, County of Morris, State of New Jersey, as follows:

- 1) The Town of Boonton hereby accepts and relies upon the December 15, 2020, notice of retirement from Lidia Ienaro, seeking to retire effective May 1, 2021.
- 2) Effective May 1, 2021, Lidia Ienaro shall be retired from her position as Clerk Typist from the Town of Boonton.
- 3) The retirement of Lidia Ienaro is hereby irrevocable as Ms. Ienaro is only afforded terminal leave upon retiring from service with the Town of Boonton as set forth in the Employee Handbook.
- 4) The Town of Boonton hereby ratifies and approves the Terminal Leave Agreement executed by Ms. Ienaro on December 15, 2020 and the Mayor should also execute same.
- 5) This resolution puts the Town Administrator and CFO on notice to immediately process any and all requests from the State of New Jersey, Division of Pensions and Benefits regarding the retirement of Ms. Ienaro.
- 6) This resolution shall take effect immediately.
